Smith says California should impose a wealth tax on Californians who have a net worth over \$50 million in addition to the normal income tax they pay. This would capture more revenue from the super-wealthy and ensure they pay their fair share.

Jones says California imposing such a wealth tax is a bad idea. It is difficult to know how much a super-wealthy person is actually worth, imposing that type of tax would encourage them to leave the state, and the threshold will eventually be reduced so ordinary residents will also be taxed on their net worth.
